INSTRUCTIONS:

1. The nomination will be registered only when it is complete in all respects including the signature of (a) all registered holders and (b) the nominee. Details of all security holders in a folio need to be filled; else the request will be rejected.
2. The nomination can be made by individuals only. Non individuals including Society, Trust, Body Corporate, Partnership Firm, Karta of Hindu Undivided Family, holder of Power of Attorney cannot nominate.
3. If the Shares are held jointly, all joint holders are required to sign the nomination form. A non-resident Indian can be a nominee on re-pitiable basis.
