4: First aid measures

4.1 Description of first aid measures

First-aid measures general : Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

4.3. Indication of any immediate medical attention and special treatment needed

5: Firefighting measures

5.1 Extinguishing media

- Suitable extinguishing media : Dry Powder / Foam/ water fog /water spray

5.3 Advice for Firefighters

- Firefighting Instructions : LARGE FIRE: Water spray, fog or regular foam. Move containers from fire area if you can do it without risk. Dike fire-control water for later disposal; do not scatter the material. Use water spray or fog; do not use straight streams. FIRE INVOLVING TANKS OR CAR/TRAILER LOADS: Fight fire from maximum distance or use unmanned hose holders or monitor nozzles. Do not get water inside containers. Cool tanks/drums with water spray/remove them into safety location. Do not move the load if exposed to heat. Take account of toxic fire-fighting water. Use water moderately and if possible collect or contain it.
- Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection

6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

6.1.1 For non-emergency personnel

- Protective equipment : Corrosion-proof suit. Refer "Material-Handling" to select protective clothing. Mark the danger area. Consider evacuation. Close doors and windows of adjacent premises. Stop nearby engines and no smoking. Keep containers closed. Wash contaminated clothes. As an immediate precautionary measure, isolate spill or leak area in all directions for at least 50 meters (150 feet)
- Emergency Procedures : for liquids and at least 25 meters (75 feet) for solids. SPILL: Increase, in the downwind direction, as necessary, the isolation distance shown above. FIRE: If tank, rail car or tank truck is involved in a fire, ISOLATE for 800 meters (1/2 mile) in all directions; also, consider initial evacuation for 800 meters (1/2 mile) in all directions. 6.1.2 For emergency responders

- Protective equipment : Equip cleanup crew with proper protection. Wear positive pressure self-contained breathing apparatus (SCBA). Wear chemical protective clothing that is specifically recommended by the manufacturer. It may provide little or no thermal protection. Structural firefighters' protective clothing provides limited protection in fire situations ONLY; it is not effective in spill situations where direct contact with the substance is

Prevent soil and water pollution. Prevent spreading in sewers, water bodies.

6.3 Methods and material for containment and cleaning up

For Containment : Measure the concentration of the explosive gas-air mixture. Provide equipment/receptacles with earthing. Do not use compressed air for pumping over spills.

Methods of cleaning up : Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Scoop spilled substance into closing containers. Clean contaminated surfaces with an excess of water. Take collected spill to manufacturer/ authorized disposal facility. Wash clothing and equipment after handling

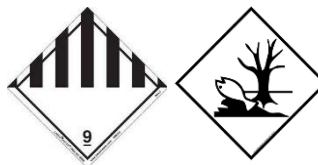
